

## The Third Meeting of Scandinavian Slavists

was held in Oslo 20th–26th August 1961 with participation of about 60 Scandinavian Slavists and Baltologists.

2. Two commissions were held on the following subjects:

The Scandinavian Association of Slavists; under this the question of the change of statutes; and

The status of the teaching of Russian in the Scandinavian countries, introduced by: Stig Surland (Denmark), B. E. von Pruschewsky (Finland), Siri Sverdrup Lunden (Norway), and Gunnar Jacobsson (Sweden).

3. In connection with this meeting, The Association of Scandinavian Slavists held their General Assembly.

*Preceptor* Gunnar Jacobsson (Gothenburg), substitute *assistent* Ingeborg Holm (Gothenburg).

Professor Ad. Stender-Petersen was elected editor in chief and *magister* Knud Rahbek Schmidt assistant editor.
